

**NOTICE OF PUBLIC HEARING

**IN THE MATTER OF: City of Steinbach (the “City”) Zoning By-law No. 2241 (the “Proposed By-law”) amending Zoning By-law No. 2100. The Proposed By-law seeks to rezone NW 82.5 feet and SE 82.5 feet of Lot 7 Block 3 Plan 3906 (also known as 268 Home Street and 274 Home Street) in the City of Steinbach from “RLD” Residential Low Density to “RMD” Residential Medium Density.**

**AND IN THE MATTER OF: Objections to the Proposed By-law received by the City and referral of the objections from the City to The Municipal Board (the “Board”) under Section 77(5) of *The Planning Act*.**

PUBLIC NOTICE is hereby given that, under the provisions of *The Planning Act*, **C.C.S.M**, c. P80 and *The Municipal Board Act*, **C.C.S.M**, c. M240, the Board will hold a public hearing to receive representations from any person in respect of the objections to the Proposed By-law.

The public hearing will take place on **Wednesday, August 14, 2024**, at **9:30 a.m.** and, if needed on, **Thursday, August 15** and **Friday, August 16, 2024** at **9:30 a.m.** at the **Fireside Room, Pat Porter Active Living Centre, 10 Chrysler Gate, Steinbach, Manitoba.**

Any interested person may make a representation on the Proposed By-law. A person who wishes to make a written and/or oral presentation to the Board must register by filing a completed Public Presenter Form with the Board at least ten (10) working days prior to the hearing.

The Board requires that an interested person who intends on filing a written submission must file four (4) copies of that material with the Board and one (1) copy with the City of Steinbach for public viewing at least ten (10) working days prior to the hearing, failing which copies of the written submission must be provided to the Board and the parties at the hearing.
